2023-2024 STUDENT PARKING
RULES AND REGULATIONS

At this time student parking permits will be issued to SENIORS ONLY. At this time Juniors are not eligible for year long parking passes. Grade 10 students will not be eligible at any time for a parking pass.

All Seniors in good standing who submit a completed application will receive a parking permit. Any Senior who wishes to park on campus must complete a parking application and provide the required documents. Any information submitted last year is invalid and new paperwork must be submitted. Applications may be submitted to Mrs. Lapierre in the Media Center as follows:

Friday, August 25th and Monday August 28th, 12:30pm -2:30pm
Tuesday, August 29th from 9:00am -2:00pm.

Student parking is a privilege and may be revoked, with no refund, if a student violates any driving or parking rule or has chronic behavioral infractions. There is no excuse for tardiness to school. Student drivers should expect heavy traffic on Main Street (Route 122A) and factor that into their driving time. Student drivers should not use "car trouble" as an excuse for tardiness, as this also may jeopardize their parking permit. By driving safely and obeying these regulations, you will maintain your parking privilege and promote safe transportation on our campus. All drivers must observe these rules for driving and parking on the WRHS campus:

1. Student drivers may park only in the numbered parking spot issued to them. Students are not allowed to park in the faculty parking lots or anywhere else on school grounds. Those parking illegally will be ticketed and their cars may be towed. Parking privileges of chronic offenders will be revoked.
2. Stickers must be displayed on the bottom left, driver's side, of the rear window. Failure to comply will result in a ticket.
3. Student drivers must obey the 15-mile-per-hour speed limit as well as all one-way, exit, and stop signs posted on the school campus.
4. Student drivers must leave their cars locked in the parking lot during the school day. They are not allowed to go to their cars without permission or to allow other students to do so.
5. Students must not leave the school campus in their cars during the day without permission.
6. Student drivers must wait for and then follow the line of school buses and vans as they leave the parking lots and driveways at the end of the day. ***Any student drivers who attempt to cut off, drive in front of, or interfere with the buses or vans in any way will be committing a safety violation and will lose parking privileges for one month on the first offense.*** A second offense will result in revocation of the student parking permit for the remainder of the school year.
7. All other safety violations committed by student drivers on school property – such as speeding, exiting via the wrong exit, "peeling out," interfering with the safe operation of other vehicles, etc. – will also result in the revocation of the student parking permit for one month on the first offense and permanent revocation on the second offense.
8. Multiple family vehicles may be registered for one student driver. The parking sticker will be placed on the primary vehicle. **If the student is driving a different registered vehicle they must notify the Upper School office (B201) upon entering the building.**
9. Parking permits are non-transferable and are only valid for the student who has received an approved parking permit.

Student parking applications will be screened for completeness and accuracy.

Student parking permits cost \$150 for one year. To be considered for a permit, students must not have had significant behavioral infractions during the previous school year or any outstanding school debts.

To apply for a parking permit, complete this form and bring or mail it, along with a \$150 check payable to WRSD, to 1401 Main Street, Holden, MA 01520.

Attach to this application *copies of:*

- 1) **Your driver's license**
- 2) **The registration for the vehicle(s) you intend to park at school**
- 3) **Your vehicle(s) insurance coverage sheet(s)**

According to school district policy, all high school students applying for parking permits are required to carry personal liability insurance on their vehicle in the amount of **\$100,000 - \$300,000 (Line item 5)**. Students must verify this coverage by submitting a copy of their insurance coverage sheet with their permit application. Applications submitted without this verification or indicating less liability coverage than is required will not be issued a permit.

We certify that all the above information is accurate and that this WRHS student qualifies for a student parking permit. We understand that the parking sticker must be displayed on the bottom left, driver's side, of the rear window. Failure to comply will result in a ticket.
